

# 2020 REMOTE LEARNING ACKNOWLEDGEMENTS

1. (initial) \_\_\_\_\_ do acknowledge that I have read a copy of the LCA Handbook explaining the policies and procedures of Leland Christian Academy. I agree to abide by the policies and procedures as set forth in the handbook and will ask questions or schedule a conference when I have concerns.
2. (initial) \_\_\_\_\_ give permission for our child's teacher or the administration of the school to make and enforce classroom regulations in a manner consistent with Christian with Christian principles and discipline as set forth in the school's Disciplinary Policies statement. The teacher and administration is hereby given full discretion in the discipline of our child.
3. (initial) \_\_\_\_\_ do acknowledge that I have read a copy of the Summary of North Carolina Child Care Law and Rules.
4. (initial) \_\_\_\_\_ do acknowledge that our child's tuition is due at the beginning of each week for Remote Learning.
5. (initial) \_\_\_\_\_ do acknowledge I am aware of the LCA illness/fever policy. However, due to the COVID-19 pandemic, we are requiring a doctor's note for your child to return to school if sent home with illness or fever.
6. (initial) \_\_\_\_\_ We agree that the academy staff may authorize the physician of their choice to provide emergency care in the event that neither we nor the family physician can be contacted immediately.
7. (initial) \_\_\_\_\_ We understand that attendance at Leland Christian Academy is a privilege and not a right. The school reserves the right to dismiss any student who does not cooperate with the educational process or who does not conform to the standards and regulations of the academy. If a student leaves the academy for any reason, tuition may be prorated; however, other fees may also apply (please consult the Parent-Student Handbook for further information).
8. (initial) \_\_\_\_\_ If we take legal action against Leland Christian Academy on our child's behalf and the academy is not found at fault, we agree to pay any attorney fees, court fees and any other costs that Leland Christian Academy should incur to defend itself against such action.

## AUTHORIZATION TO PARTICIPATE IN FIELD TRIPS

This authorization is valid ONE YEAR from the date it is signed. We give permission for our child to take part in all school activities including the school sponsored trips away from the school premises. (Notification of said trips will be given to the parents in advance.) This includes on premise activities outside fenced playground areas.
